Title of project:	What can the United Nations War Crimes Commission teach us about the principle universal jurisdiction today?

Summary of findings:

There are two key findings from this project.

First, this project has brought together academics from all over the world who work on the topic of the United National war Crimes Commission (1943-48) (UNWCC). This was achieved by organising a workshop and an international conference, the calls for which were advertised publicly. Moreover, this group of scholars is in from a range of disciplines including law, politics and history.

Second, the research aspect of this project has resulted in academic findings regarding the scope and application of the principle of universal jurisdiction during the operation of the UNWCC. With the help of a Research Assistant (funded under the Charlemont Grant), I was able to go through 100s of trial reports from the UNWCC cases in the online archive. Here, we identified cases where universal jurisdiction was relied on, how the principle was applied, what crimes it applied to and other interesting points of note. I am writing an article on the basis on this information for submission to a high ranking academic journal early next year.

Plans for continuing collaboration:

In addition to the article that I am drafting mentioned above, I am writing a paper with Prof Dan Plesch (Director of the Centre for International Studies and Diplomacy, the School of Oriental and African Studies (SOAS) in the University of London) and Lennart Poulsen (Barrister, Chambers of Steven Kay QC, 9 Bedford Row) on the application of universal jurisdiction to crimes against cultural heritage under the UNWCC.

Second, following on from the workshop and conference held as part of this project, along with Prof Dan Plesch, I am establishing a network of interested scholars to continue to momentum and interest in these events. Here, we are organising a meeting in the coming weeks to brainstorm on ideas to bring together the network of interested scholars from a range of disciplines.

Published work and publication plans:

I am writing an article on the scope and application of universal jurisdiction under the UNWCC and how it can be used as state practice in support of the principle in modern times. This article will be submitted to a high ranking academic journal early next year.

I am writing a paper with Prof Dan Plesch and Lennart Poulsen on the application of universal jurisdiction to crimes against cultural heritage under the UNWCC. This research will also be presented at 9 Bedford Row Barristers Chambers in the UK, of which Prof Plesch and Mr Poulsen are members.

Myself and Dan Plesch organised an online conference as part of this project, which took place on 19 November. We have selected the best papers from this event, the writers of which will be asked to take part in a blog symposium stemming from the conference.

Dissemination and plans for future dissemination:

The research conducted on the exercise of universal jurisdiction under the UNWCC was presented at a workshop I organised as part of the project in May 2021, and also at an online conference I organised in November 2021.

This research I am completing with Prof Dan Plesch and Lennart Poulsen will also be presented at 9 Bedford Row Barristers Chambers in the UK, of which Prof Plesch and Mr Poulsen are members.
